M/s A.S. FOODS, a partnership firm having registered office at #39, 1<sup>ST</sup> Floor, OM Heera Panna Mall, Oshiwara, Andheri West, Mumbai -400053 had been associated with PEC Ltd. for financing of Agro Commodities meant for export. They have wilfully defaulted in honouring their commitment /payment obligations of **Rs.46 crore approx.** to PEC. Further pursuant to direction of Second Level Committee of PEC Dated:12.10.2016. It has been decided to **blacklist/debar** M/s A.S. FOODS as per circular no. 2/15 of PEC Dated:18.08.2015 which is available at PEC website ([www.peclimited.com](http://www.peclimited.com)) and restrain them to make any further import, Export, and Domestic Trade with PEC & its office till clearance of their dues to PEC Ltd. for a period of 3 years.

M/s A.S. FOODS has been found to be guilty of impropriety & irregularity and has failed to meet contractual obligation & pay outstanding amount to PEC Ltd. Therefore PEC has prohibited all its offices from entering into any further trade transactions with the M/s A.S. FOODS for a period of 3 years.
